Name of Patient: Dr. Purshottam Bagul

Age: 40 yrs

Resident of: Malegaon (place @ 300 kms from Pune): Dr. Bagul is having a 15 bed ICU multispeciality hospital at Malegaon city.

Problem Diagnosis

Around 5 years back , Dr. Bagul was diagnosed with having H/O DVT right leg and later on developed varicose vein . From around one and a half years, he developed varicose ulcer on left leg. The ulcers used to take months to heal and Dr. Bagul was under immense pain and also his mobility was very restricted. Around one and a half months ago he again developed the varicose ulcer which becoming gangrenous. As per the local consulting surgeon he was advised to undergo for gangrene tissue and plastic surgery.
